

## **PRIVACY NOTICE - APPLICANTS FOR SCHOLARSHIP**

This privacy notice describes how AWM Network ApS, a company incorporated in Denmark with company registration number 35805702 and whose registered office address is Høffdingsvej 34, 2500 Valby, Denmark, the “Controller” handles the personal information of applicants for scholarship with AWM Network ApS.

### **1. What data we collect and how**

To the extent under the applicable law, we collect information about you when you:

- Make a scholarship application
- Contact us by telephone, fax, SMS, email or post.
- Contact us through other channels like social media portals.

AWM Network ApS may collect and process the following categories of data in the context of your current application for scholarship:

- Name and Surname
- Email address
- Phone number
- Certificate of student enrollment
- Student card
- Motivation Essay
- CV
- Business Plan

### **2. How we use your data**

AWM Network ApS process your personal data for the purposes of consider, review and possibly award you a scholarship on the following legal basis:

- Your consent, where required and to the extent of applicable law.

### **3. Transferring your data**

Personal information in the European Union is protected by data protection laws, but other countries do not necessarily protect your personal information in the same way.

Some of our services, or parts of them, may also be hosted in the United States or otherwise outside of the EEA (which means all EU countries including Norway, Iceland, and Liechtenstein) and this means that we may transfer any information which is submitted by you outside the EEA to the United States or to other territories outside of the EEA. When you send an email to us, this will also be stored on our email servers, which are hosted in the United States.

We take steps to ensure that where your information is transferred outside of the EEA by our service providers and hosting providers, appropriate measures and controls are in place to protect that information in accordance with applicable data protection laws and regulations. In each case, such transfers are made in accordance with the requirements of Regulations (EU) 2016/679 (the General Data Protection Regulations or “GDPR”) and may be based on the use of the European Commission’s Standard Model Clauses for transfers of personal data outside the EEA.

By interacting with us in the ways described in this Privacy Notice, you consent to the transfer of your information outside the EEA in the circumstances set out in this Privacy Notice. If you do not want your information to be transferred outside the EEA, you should not use our website or services.

#### **4. Storing your data**

Data is processed for as long as you are in the application process and for up to 2 years after this.

#### **5. Your rights**

If you are based within the European Economic Area (“EEA”) or within another jurisdiction having similar data protection laws, in certain circumstances you have the following rights:

- the right to be told how we use your information and obtain access to your information;
- the right to have your information rectified or erased or place restrictions on processing your information;
- the right to object to the processing of your information e.g. for direct marketing purposes;
- the right to have any information you provided to us on an automated basis returned to you in a structured, commonly used and machine-readable format, or sent directly to another company, where technically feasible (“data portability”);
- **where the processing of your information is based on your consent, the right to withdraw that consent subject to legal or contractual restrictions;**
- the right to object to any decisions based on the automated processing of your personal data, including profiling; and

- the right to lodge a complaint with the supervisory authority responsible for data protection matters (e.g. in Denmark, Datatilsynet).

If we hold any information about you which is incorrect or if there are any changes to your details, please let us know so that we can keep our records accurate and up to date.

If you withdraw your consent to the use of your personal information for purposes set out in our Privacy Notice, we may not be able to provide you with access to all or parts of our services.
